Mr. Ottinger is an experienced arbitrator and mediator in oil and gas matters, having completed formal training through the Straus Institute for Dispute Resolution, Pepperdine University School of Law, presented at Woodstock, Vermont, in September 2012. Among other matters, he served as the neutral chair of an arbitration panel in Houston, Texas, a case concerning a dispute between parties to a gas processing agreement where the damages were alleged to be in the range of \$250 million. He also served as a co-mediator in a coal bed methane case in Birmingham, Alabama, where damages were alleged to be in the range of \$ 300 million. He is listed on the AAA Energy Panel for the arbitration of complex disputes involving oil and gas, or energy-related matters.

Mr. Ottinger is listed on the Energy Arbitrators List of the Institute for Energy Law, which is a directory of individuals with "substantial experience in the arbitration of energy disputes."

Patrick S. Ottinger graduated from the University of Southwestern Louisiana with a Bachelor of Science degree in 1971.
